### CODE OF CONDUCT:

Both scholars and parents/legal guardians must read and sign below

- All participants are expected to show respect to each other as well as to the MKC staff, facility, and equipment. Each participant will be held responsible for his/her actions and behavior. Uncooperative participants may be asked to leave.
- Drugs, alcohol, and tobacco products are not allowed within the facility or on the grounds. Anyone in attendance or attempting to enter who is under the influence or in possession of alcohol, illegal drugs or illicit substances will be asked to leave. Parents and/or police will be notified.
- Weapons and items that may be considered weapons are forbidden. Anyone found to be in possession of such items will be required to leave and items will be confiscated. This includes laser pointers. Parents and/or police will be notified as appropriate.
- Violence or threats of violence will not be tolerated within the facility, on the grounds, or at MKC sponsored events.
- Food and beverages must be kept in designated areas.
- Any damage to MKC property will be paid for by the person responsible.
- Use of abusive, obscene, or profane language, including racial, religious, or sexual references directed at others, will not be tolerated. Please remember to treat others as you would like to be treated.
- Inappropriate or disruptive behavior is not permitted in the facility. This includes but is not limited to graffiti, littering, spitting, or throwing objects.
- No teen shall commit any act which furthers or promotes gangs or gang-related activities. This includes but is not limited
  to wearing, displaying, or distributing any clothing, jewelry, symbols or other items which may be evidence of
  membership in any gang.
- All who enter the Maria Kaupas Center are expected to comply with the Code of Conduct standards. Anyone who
  disrupts the operations of the Center may be asked to leave the property. MKC staff has the authority to prohibit such
  persons from attending future events.

## STUDENT CODE OF CONDUCT CONSEQUENCES:

AGREEMENT AND ACKNOWLEDGEMENT

If code of conduct is broken, the following actions will be taken in this order:

- Student will receive 2 verbal warnings.
- If code of conduct is broken a 3<sup>rd</sup> time, the student will be asked to clean in the center for 30 minutes (sweeping, dusting etc.)

- If student misses the assigned cleaning duty, he/she will be suspended from the MKC until the duty is complete.
- If student behavior continues not to represent the values of the MKC, a parent conference will be scheduled.
- If student behavior continues not to represent the values of the MKC after a parent conference, the student will be asked to no longer attend the center until staff states otherwise.
